
The Director's Report and Finance Report were taken as read.

# 5.1 Future of Equality Legislation Advisory Committee Report (FELAC) - Part One

FELAC Report Part One presents the FELAC's 39 headline recommendations to the Commission arising from its work so far. There are a number of issues still due to be considered by the FELAC, which will be presented to the Commission in FELAC Report Part Two, due for completion by mid-May. Both FELAC reports will feed into IHREC's second submission to the Department's Review of the Equality Acts, which will be submitted to the June Plenary Meeting.

Members approved the report and paid special tribute to the work of the members of FELAC for their significant contribution to the work of the Commission.

SG confirmed that she is considering how to best display their gratitude to the Committee and noted her hopes for the Committee to meet in person for the first time.
